PENSACOLA STATE COLLEGE is proud to help strengthen nonprofit and philanthropic organizations through education and management designed to support board governance, enhance the business practices of nonprofit organizations, and expand the influence of the nonprofit sector. Each year the institute offers certified fundraising executives (CFRE) credit for their mastery of skills and information shared through Pensacola State College's Nonprofit Center for Excellence workshops.

Attendees benefit from professional trainers and expert panelists who equip attendees with best-practices and practical template that can be used in their organizations. Workshops help attendees earn continuing education units necessary to secure and renew certification as a Certified Fund Raising Executive.

Naming Opportunities

Significant gifts to the college provide opportunities for donors to designate the name of a college facility or program in honor of the donor or another person. Scholarships, endowed chairs, lecture series, and faculty and staff awards programs are among the named gift opportunities, as are buildings or portions of buildings, including laboratories and conference rooms. Naming opportunities range from \$10,000 to \$5,000,000 and are offered in recognition of a single, tax-deductible,

CAPITAL NEEDS:

Currently the available spaces on campus have limited seating and do not meet the training and conferencing needs of the College.

- Software/Membership Resources for Nonprofit Center Members (BoardSource, Foundation/Grant search, Quickbooks, Society for Nonprofits affiliate membership, graphic design)=\$8,541 annually
- Computers for Networking Center=\$15,000
- Computer desks and tables=\$36,000
- Renovation of current classroom and computer lab space= \$50,000
- Program Endowment=\$500,000
- Scholarship Endowment=\$500,000

THE NEED:

The only nonprofit centers offering degrees in nonprofit management and certification for fundraising professionals are in Central and South Florida at UCF, USF and the Edyth Bush Institute at Rollins College. With over 6,839 nonprofit organizations in our region, an affordable and accessible resource for best practices, networking and continuing education is essential to ensuring local resources are efficiently and effectively utilized. The numbers by county (below) indicate numerous nonprofits could utilize a regional center to grow their business and nonprofit acumen. It is important that we are ensuring this sector has the workforce and the education needed to meet the social sector needs of our growing region. With \$6,569,649,970 in assets in the six counties below, this sector is an important part of our regional economy.

- 875 nonprofit organizations in Santa Rosa County, FL (Assets total=\$313,497,598)

- 520 Organizations in Walton County, FL (Assets total= \$468,468,587)
- 651 Organizations in Jackson County, FL (Assets total= \$211,272,784)
