Pillar 1 | Growth & Development of PSC

By 07.01.22, a comprehensive plan will be developed to support the College priorities by increasing public/private partnerships by 25% utilizing the appropriate timeframe established by the plan.

By 12.31.22, we will have a baseline of student and family giving and will increase giving 50% by the end of 2024.

Pillar 2 | Changing Lives Through Affordable/Quality Education

By 12.31.22, PSCF will be able to offer (every student that applies) help that enables them to graduate without debt by providing resources to increase debt free graduating status to 97%.

By 12.31.22, the PSC Foundation will encourage a 5% increase in traffic to the scholarship application site.

By 12.31.22, PSCF board members will have identified, engaged, and solicited enough donor prospects to increase the three-year trend of new scholarships being established by 5%.

By 12.31.23, the PSC Foundation will have recruited funding for one additional endowed teaching chair.

Pillar 3 | Community Enhancement/Post Graduate Workforce

By 08.31.22, PSCF will create a funding stream the Marketing & Communications Coordinator can use to create an environment that compels individuals, corporations, and foundations in the community to donate and get involved in the Foundation's work to support the College.

By 08.31.23, PSCF will create an endowment to promote available workforce resources to the community (such as JobX, internships, and the availability of co-ops and student experiences). The Foundation will grow donations to the endowment to \$100,000 by the end of 2024.

14 Workshops, 234 Attendees, & 40 Nonprofits

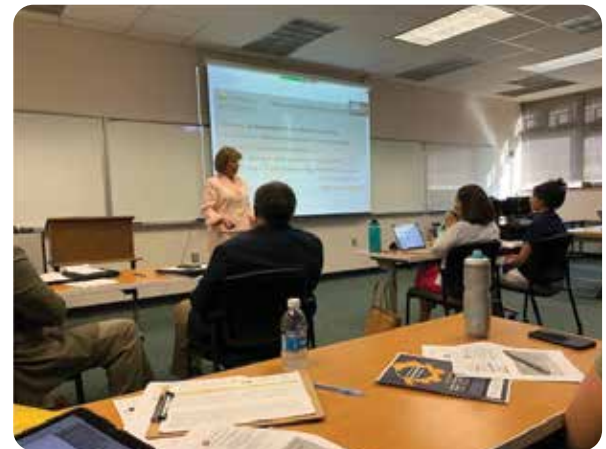

We are grateful to the **148 shooters, guests, and volunteers** that enjoyed activities and awards provided by event and in-kind sponsors.

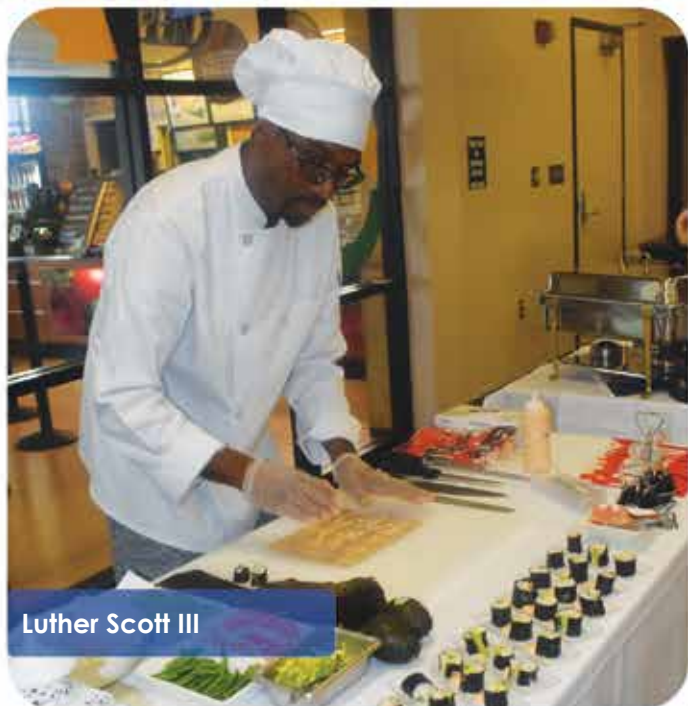

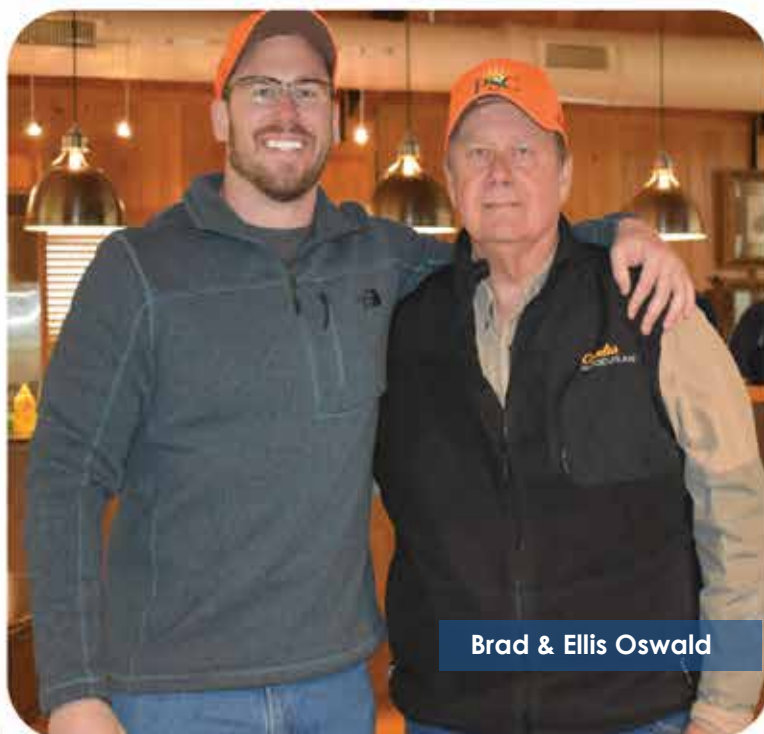

In November of 2018, PSC launched the Your Community Your Legacy Campaign to raise \$11 million in **four key areas**. Despite Hurricane Sally, the destruction of the three-mile bridge and a worldwide pandemic, we exceeded the \$11 million goal.

Workforce

Supporting PSC's contribution to local Workforce development, gifts were made toward the construction of a new STEM building, the Nonprofit Center for Excellence, programing to improve education in the Health Sciences, the truck driver training and trade programs. Donors contributed **\$4.65M** toward the **\$4.05M** fundraising goal.

Scholarships

The COVID pandemic reinforced the need for financial support for students. We were thrilled that in addition to general Scholarships, donors designated to create vocational and technical scholarships, named endowments, first generation and matching fund endowments, and scholarships to support the health sciences and Veterans and their families. Volunteers raised **\$3.3M**, almost **\$200,000** over the campaign goal.

Training & Conference Center

With the Hurricane and pandemic forcing the closure of New World Landing and other event spaces, a quality training space for students and community nonprofit conferences is desperately needed. Lead donors Jan and Ron Miller provided a jump start that allowed us to reach **\$1.9M** of the **\$2.8M** goal toward building a new PSC Training and Conference Center. We look forward to continuing this endeavor as the College's **#1 PRIORITY** for State funding in the coming year.

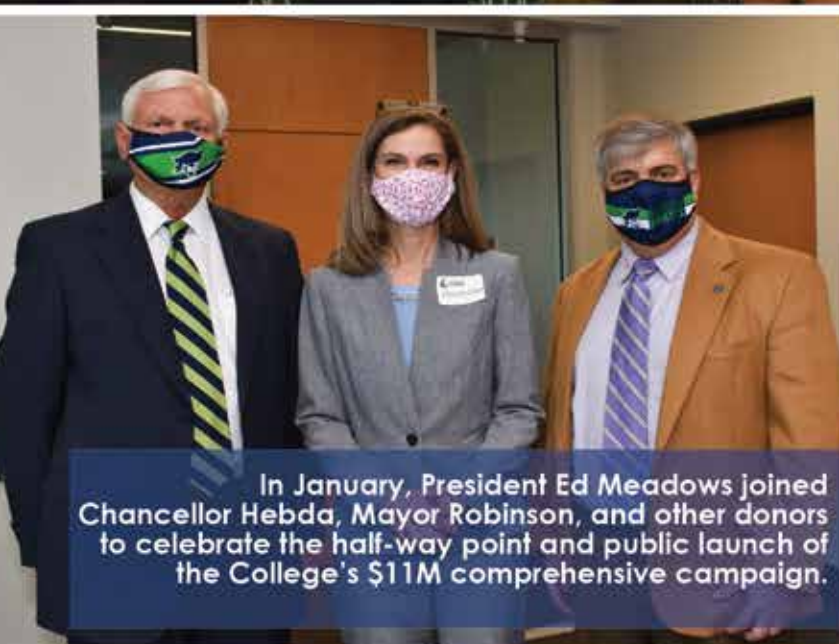
Fund for Excellence

The Fund for Excellence is an unrestricted fund that allows The Foundation flexibility to meet the College's greatest needs FIRST. A donor-supported advancement fund, PSC relies upon this resource to maximize opportunities to grow and expand. Volunteers raised **\$1.17M** that could be used to help ensure faculty and staff have professional development opportunities. The fund also supports satellite campuses and centers, provides GED, skilled trade and center programmatic growth, and to support athletic, performing arts, visual and culinary arts program enhancements.

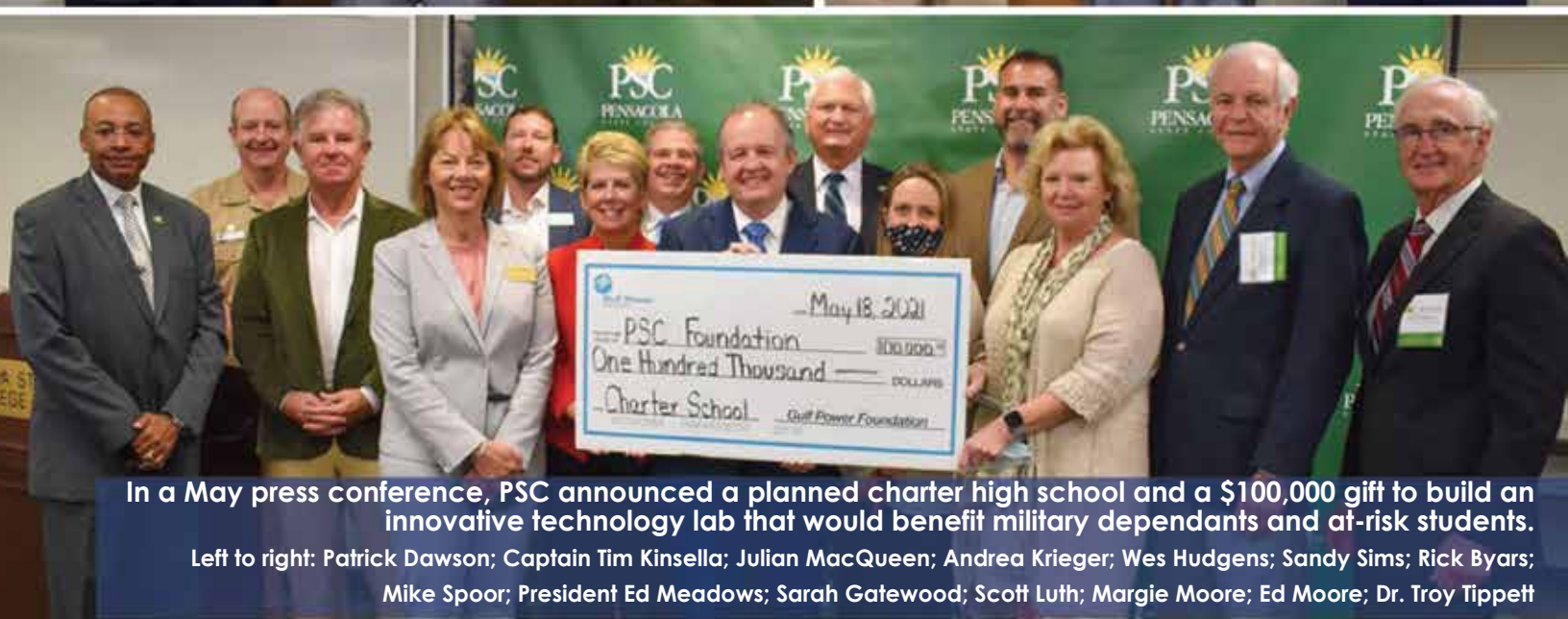
